





Prime paint the ceiling in Room 3108C, then finish paint with Sherwin Williams ProMar 200 B30-2600 Series  
2 "White" with a flat finish.




3 Patch and paint the walls in Rooms 3108E and 3108F Benjamin Moore "Linen White" with an eggshell finish.



Paint the walls of Rooms 5500I and 5500J Benjamin Moore "Linen White" with an eggshell finish. Paint the ceiling Sherwin Williams ProMar 200 B30-2600 Series "White" with a flat finish.




Paint the walls, above the millwork wainscot, in Room 3917B and 3917B Pratt & Lambert 1309 "Honeydew" with an eggshell finish.



Remove the existing carpet from rooms 4335, 4335A, 4335B, 4335C, and 4335D and dispose of it off site. Provide new PacifiCrest broadloom carpet, Molten ML162-02 Torrid , in rooms 3108, 3108A, 3108B, 3108C, 3108D, and 3108F highlighted in the attached drawing. Contractor shall prepare the floors and provide an adhesive that is in accordance with the manufacturer's recommendations. Provide any miscellaneous

6 materials necessary to finish the project.



Remove the existing wallcovering and chair rail from the rooms highlighted above and dispose of it off site. Patch and paint the walls in the rooms highlighted above Benjamin Moore HC-81 "Manchester Tan" with an eggshell finish. Provide any miscellaneous materials necessary to finish the project.

Paint the ceilings in the rooms highlighted above Sherwin Williams ProMar 200 B30-2600 Series "White" with a flat finish. Provide any miscellaneous materials necessary to finish the project.

Terms:

1	Work shall be done on weekends or outside of normal working hours (Monday through Friday, 7:00 a.m. to 5:00 p.m.)
2	Contractor to submit name, date of birth, and social security number of all workers that will be working on site for this work scope. Submit information after being notified that the proposal has been accepted by the courts. A background check will be performed against the information provided. A purchase order will be issued upon notification that workers are suitable to work, unescorted, in the courthouse. Should it be determine that workers are not suitable a purchase order will not be issued. In this event, an explanation will not be provided; all decisions are final. <u>Not applicable to workers who have already been cleared to work in the building in the preceding six months.</u>
3	Contractors shall work in assigned space only. Contact Justine Birrane for escorted access to and from the work location.
4	Contact Scott Ellermets or Justine Birrane to schedule a review of the space in advance of proposal submission.

5	Contractor shall take all necessary steps to protect the existing space, typically including plastic protection over nearby surfaces. Contractor shall move furniture and equipment as necessary to complete work. The courts shall move computers, phones, and electronic equipment as necessary.
6	The contractor shall follow all relevant OSHA requirements. <b>Safety glasses, long pants, short-sleeve shirts (as a minimum) and appropriate footwear shall be worn at all times.</b>
7	<b>Provide proposal no later than August 17, 2015.</b>
8	<b>Work shall be completed no later than December 18, 2015.</b>
