Public Advisory – January 9, 2024, Oral Arguments in No. 23-3228, United States v. Donald J. Trump

**Argument Date & Time:** Tuesday, January 9, 2024, at 9:30 a.m.

**Courtroom:** Oral arguments will be heard in Courtroom 31 on the fifth floor. Everyone entering the courtroom will be subject to additional security screening.

**Overflow Courtroom:** An audio-video feed of the oral arguments will be broadcast to Courtroom 24 located on the fourth floor. All rules pertaining to Courtroom 31 (e.g., restrictions on the use of electronic devices) apply to the overflow courtroom.

**Public Seating:** Public seating in the courtroom and in the overflow courtroom is limited and will be on a first-come, first-seated basis.

**Media Seating:** There will be a limited number of seats reserved for the media in the courtroom. Media will be seated on a first-come, first-seated basis until all the media seating is filled. No electronic devices may be used in the courtroom. There will be one line for members of the public and the media.

**Media Rooms:** There will be two media rooms where members of the media can watch the audio-video feed of the oral arguments and use electronic devices. The media rooms are located on the first floor (Room 1131B) and the fifth floor (Room 5205). Broadcasting, streaming, or recording the video is strictly prohibited. The same rules that apply to the District Court's media rooms apply to the Court of Appeals' media rooms (Media Policy).

**Seating for the Parties:** There will be a limited number of seats set aside for the arguing attorneys. The arguing attorneys have a point of contact to handle their reserved seating allocations. Persons with reserved seating should arrive at the courtroom no later than 8:45 a.m.

**Line Standers:** Only individuals who plan to attend the oral arguments will be allowed to line up inside the courthouse. Line standers inside the courthouse are not permitted. No one will be allowed to hold spaces for other individuals inside the courthouse.

**Live Streaming Audio:** The audio of the oral arguments will be live streamed on the Court's YouTube channel. To minimize congestion on the Court's website, the public is encouraged to go directly to the YouTube channel using this link: <a href="https://www.youtube.com/USCourtsCADC">https://www.youtube.com/USCourtsCADC</a>.

**Audio Recordings:** An audio recording of the oral arguments will be available on the Court's website by 3:00 p.m. on January 9, 2024.

**Courthouse Entrances:** The 3<sup>rd</sup> Street, John Marshall Park, and Constitution Avenue entrances will open to the public at 7:00 a.m. The John Marshall Park and Constitution Avenue entrances will be closed from 9:30 a.m. to 12:00 p.m. The 3<sup>rd</sup> Street entrance will remain open all day.

**Security Screening:** Individuals attending the oral arguments should allow sufficient time to pass through security screening. Please keep in mind there will be other court activity in the courthouse that may affect how long it takes to clear security. For more information, see the <u>Security Screening Protocols</u>.

Use of Electronic Devices: All visitors must follow the Electronic Device Policy.

Courthouse Decorum: All visitors must follow the Courthouse Decorum Policy.

**Press Conferences and Media Interviews:** Press conferences and media interviews may not be conducted inside the courthouse. Press conferences are typically held in front of the courthouse on the plaza facing Constitution Avenue. For more information, see the <u>Media Policy</u>.
