


Figure 3. Filing Category: Brief (Appendix Not Deferred)




Figure 6. Filing Category: Brief (Supplemental or Errata to Brief)




Figure 7. Filing Category: Certificates




Figure 9. Filing Category: Letters




Figure 10. Filing Category: Motion




Figure 11. Filing Category: Notices




Figure 13. Filing Category: Petitions




Figure 14. Filing Category: Record




Figure 15. Filing Category: Report




Figure 16. Filing Category: Responsive Documents




Figure 16. Filing Category: Statements and Initial Submissions




Figure 18. Filing Category: Stipulations
