#### **STATEMENT OF WORK (SOW)**

#### **1.1 INTRODUCTION:**

The U.S. Court of Appeals is seeking to make a "firm fixed price" award for the replacement of the "Cooling Equipment" currently servicing our fitness center. The fitness center is located on the first floor of the Prettyman side of the E. Barrett Prettyman Courthouse.


#### **2.1 OBJECTIVES:**

The Contractor is expected to replace existing cooling equipment as detailed in the "Statement of Work" below, and outlined in the "Specifications/Drawings" attached.

#### **3 SCOPE:**

1	Replace the existing cooling equipment that serves the Fitness Center in the Prettyman Courthouse with new 4 and 5-ton condensing units, air handling units and return air fans. The existing 2 and 5-ton condensing units are located in the B1 level and the air handling units and return air fans are located in the ceiling of the USMS Sally Port on the first floor.
2	Existing 2-ton capacity Air Handling Unit (EX. AHU-1) serving locker room and exercise room is replaced with a new 4-ton capacity unit (AHU-1).
3	Existing 2-ton capacity Condensing Unit (EX. CU-1) serving locker room and exercise room is replaced with a new 4-ton capacity unit (CU-1).
	Existing 5-ton capacity Air handling Unit (EX. AHU-2) serving aerobics & weight room is replaced with a new 5-ton capacity unit (AHU-2).
5	Existing 5-ton capacity Condensing Unit (EX. CU-2) serving aerobics & weight room is replaced with a new

6	Provide new refrigerant line sets for the new 4 and 5-ton cooling units.

7	Existing inline Relief Air Fan (EX. RAF-1) serving EX. AHU-1 is replaced with a new inline fan (RAF-1).
8	Existing inline Relief Air Fan (EX. RAF-2) serving EX. AHU-2 is replaced with a new inline fan. (RAF-2).
9	All the existing relief air ductwork located in sally port space is removed and a new relief air ductwork layout has been provided.

10	Existing Outside Air Fan (EX. OAF) serving air handling units (EX. AHU-1 & EX. AHU-2) is removed, and associated outside air ductwork is demolished.
10	
11	A new 1950 CFM capacity inline Outside Air Fan (OAF-1) has been provided to serve new AHU-1. New outside air ductwork from the existing has been provided.
12	A new 1600 CFM capacity inline Outside Air Fan (OAF-2) has been provided to serve new AHU-2. New outside air ductwork from the existing has been provided.
13	Existing inline exhaust fan (EX. EF) serving locker room/bathrooms shall remain.
	New supply and return ductwork from the new AHUs has been provided and connected to existing supply
14	and return ductwork in the fitness center.
	Provide new electrical service such as feeders, disconnects, breakers, and conduit for new condensing, air
15	handling, and return air units.
	Connect the new cooling system to existing DDC system for the Fitness Center. The DDC system is
16	located in the USMS Sally Port. Test proper operation of cooling and DDC system.



#### 4 SPECIAL REQUIREMENTS/INFORMATION

**4.1a** – A walk thru of the existing spaces can be arranged but will need to be scheduled via emailed request to:  $dana_bethea@cadc.uscourts.gov$ .

**4.1b** – If the Contractor intends to use a Subcontractor for any of the services detailed in this project, the Contractor shall include the name of the "sub" and provide a description of how the "sub" will be managed during performance.

#### 5 **REQUIREMENTS**

5.1 – Contractor shall review and adhere to project information as shown by references.

**NOTE**: Where brand names are indicated for deliverables, the contractor shall provide **brand name or Equal**. The contractor shall provide comparative spec sheets for any and all items for which they intend to use an equivalent to the deliverables specified in the attached drawings, no later than the proposal close date.

**5.2a** - Contractor shall organize and submit a schedule for work to be done according to the following parameters below within 15 days of award: (5.2b,c).

**5.2b** - Work shall be done during normal business hours from 7:00 A.M to 6:00 P.M., Monday through Friday, and shall be coordinated with Contracting Officer's Representatives. Contractors shall work in assigned space only, and will be escorted to and from work location by COR's.

**5.2c** - Saturdays, Sundays, and federal holidays shall be approved in advance, and shall be coordinated in with Contracting Officer's Representatives.

**5.3a** - Contractor shall submit name, date of birth, and social security number of all workers that will be working on site for this work scope. Submittal of information shall be no later than 15 days after being notified of an award.

**5.3b** - A background check will be performed against the information provided. A purchase order will be issued upon notification that workers are suitable to work, unescorted, in the courthouse.

**5.3c** - Should it be determined that workers are not suitable a purchase order will not be issued. In this event, an explanation will not be provided; all decisions are final. <u>Not applicable to workers</u> who have already been cleared to work in the building in the preceding six months.

**5.4** – Contractor shall take all necessary steps to protect the existing space and to limit the amount of dust and debris to surrounding areas. This typically includes the contractor's use of plastic protection surrounding workspace, along with entry and exit points. The contractor shall ensure that all debris is removed from the courthouse and will ensure that debris is not deposited within courthouse dumpsters.

**5.5** – Contractor shall move and protect furniture and/or equipment as necessary to complete work.

5.6 – Contractor shall provide proposal no later than 5:00 PM, September 20, 2019.

### 6.1 **DELIVERABLES**

All deliverables, (equipment and supplies) named in the project specifications and those deemed necessary by the Contractor, shall be the responsibility of the Contractor to supply and protect throughout the duration of the project. The Contractor shall coordinate the delivery of all materials and supplies with the Contracting Officer's Representatives. The courthouse has a standard loading dock and a freight elevator able to accommodate all materials specified in the Statement of Work. The court assumes no responsibility for damaged product, any corrections to defective or damaged product shall be accomplished at no additional cost to the judiciary.

### 7.1 PERIOD OF PERFORMANCE

The overall period of performance for this contract will be 09/27/19 -April 30, 2020. Work shall be substantially complete no later than January 1, 2020.

#### 8.1 **REVIEW PERIOD & ACCEPTANCE**

At the completion of the project, the Contractor shall contact the Contracting Officer to schedule a walkthrough of the completed space. The Contracting Officer, the Contractor and the Contracting Officer's Representatives will walk the space to identify any punch list items still outstanding or certify that the area is deemed to be in a "Ready State." If accepted, the Contracting Officer will issue a close out notification to the Contractor. If the project, *(or some aspect of)* is rejected, the contractor will have 10 working days to correct the deficiency. Payment will be withheld until the project has been deemed accepted.

#### 9.1 PAYMENT

The Contractor shall submit an invoice for full payment in accordance with Clause 7-125, Invoices, after receiving acceptance notification in writing from Contracting Officer. (Clauses attached).
