STATEMENT OF WORK (SOW)

1.1 INTRODUCTION:

The U.S. Court of Appeals is seeking to make a "firm fixed price" award for the carpet replacement and painting of chambers 3917, located on the Prettyman side of the E. Barrett Prettyman Courthouse. This project includes full removal of existing carpet currently located in the chambers. It will require the installation of carpet as detailed in enclosed scope.

2.1 **OBJECTIVES:**

The Contractor is expected to replace carpet, paint and patch walls and get Chambers 3917 to a "ready state" in accord with details and specifications called out in the scope.

3 SCOPE:

- **3.1** Contractor shall remove and dispose of existing carpet.
- **3.2** Contractor shall replace the existing carpet with new carpet called out in specifications, Manufacturers Brand or EQUAL.
- 3.3 Contractor shall repair, patch and paint wall of the entire chambers as specified below.


Patch and paint the gypsum board walls in the chambers with Benjamin Moore AC-42 "Grand Teton White" in egg shell finish.

Patch and paint the gypsum ceilings in the chambers with Benjamin Moore 872 "White Christmas" in a flat finish.

Patch and paint the gypsum board walls in the judge's bathroom with Benjamin Moore AC-42 "Grand Teton White" in a semi-glass finish.

Paint the gypsum ceiling in the judge's bathroom with Benjamin Moore 872 "White Christmas" in a semigloss finish.

Prepare the chambers' floor to receive new carpet by removing existing glue and debris. Provide new wall-to-wall broadloom carpet throughout the room: Manufacturer - Invision Flooring Group, Style - Fairway (N9117), Color - 9770 Pinehurst, Face Yarn - Ultron Nylon 6,6, Size - 12 Feet 3.66m), Backing - PremierBac Plus, Pattern Repeat - 24"w x 28"l.



4 SPECIAL REQUIREMENTS/INFORMATION

5 REQUIREMENTS

5.1 – Contractor shall review and adhere to project information as shown by references below:

NOTE: Where brand names are indicated for deliverables, the contractor shall provide **brand name or Equal**. The contractor shall provide comparative spec sheets for any and all items for which they intend to use an equivalent to the deliverables specified in the attached drawings, no later than the proposal close date.

- **5.2a** Contractor shall organize and submit a schedule for work to be done according to the following parameters below within 15 days of award:. (5.2b,c).
- **5.2b** Work shall be done on weekends or outside of normal business which are Monday Friday 7 AM 5 PM. Working hours shall be coordinated with Contracting Officer's Representatives indicated in Section 4.1.
- **5.2c** Saturdays, Sundays, and federal holidays shall be approved in advance, and shall be coordinated in with Contracting Officer's Representatives.
- **5.3a** Contractor shall submit name, date of birth, and social security number of all workers that will be working on site for this work scope. Submittal of information shall be no later than 15 days after being notified of an award.
- **5.3b** A background check will be performed against the information provided. A purchase order will be issued upon notification that workers are suitable to work, unescorted, in the courthouse.
- **5.3c** Should it be determined that workers are not suitable a purchase order will not be issued. In this event, an explanation will not be provided; all decisions are final. *Not applicable to workers who have already been cleared to work in the building in the preceding six months.*
- **5.4** Contractor shall take all necessary steps to protect the existing space and to limit the amount of dust and debris to surrounding areas. This typically includes the contractor's use of plastic protection surrounding workspace, along with entry and exit points. The contractor shall ensure that all debris is removed from the courthouse and will ensure that debris is not deposited within courthouse dumpsters.
- **5.5** Contractor shall move and protect furniture and equipment as necessary to complete work.

5.6 – Contractor shall provide proposal no later than 5:00 PM, July 24, 2020.

6.1 DELIVERABLES

All deliverables, (equipment and supplies) named in the project specifications and those deemed necessary by the Contractor, shall be the responsibility of the Contractor to supply and protect throughout the duration of the project. The Contractor shall coordinate the delivery of all materials and supplies with the Contracting Officer's Representatives. The courthouse has a standard loading dock and a freight elevator able to accommodate all materials specified in the Statement of Work. The court assumes no responsibility for damaged product, any corrections to defective or damaged product shall be accomplished at no additional cost to the judiciary.

7.1 PERIOD OF PERFORMANCE

The overall period of performance for this contract will be 8/1/2020 – September 25, 2020. Work shall be substantially complete no later than September 25, 2020.

8.1 REVIEW PERIOD & ACCEPTANCE

At the completion of the project, the Contractor shall contact the Contracting Officer or Representatives to schedule a walk-through of the completed space. The Contracting Officer, the Contractor and the Contracting Officer's Representatives will walk the space to identify any punch list items still outstanding or certify that the area is deemed to be in a "Ready State." If the project, (*or some aspect of*) is rejected, the contractor will have 10 working days to correct the deficiency. Payment will be withheld until the project has been deemed accepted.

9.1 PAYMENT

The Contractor shall submit an invoice for full payment after project has been deemed accepted.
