#### <u>JUDGMENT</u>

This appeal was considered on the record from the United States District Court for the District of Columbia and on the brief filed by appellant. See Fed. R. App. P. 34(a)(2); D.C. Cir. Rule 34(j). It is

**ORDERED AND ADJUDGED** that the district court's December 22, 2017 order, denying appellant's petition under 28 U.S.C. § 2241, be affirmed. The district court correctly concluded that appellant is not a "prisoner" who is "in custody," and 28 U.S.C. § 2241 therefore does not apply. <u>See</u> 28 U.S.C. § 2241; <u>see also Carafas v. LaVallee</u>, 391 U.S. 234, 238 (1968) ("The federal habeas corpus statute requires that the applicant must be 'in custody' when the application for habeas corpus is filed."). Appellant has not established that he is in appellee's custody pursuant to "an order, process, judgment or decree of a court or judge of the United States" or of a state court. <u>See</u> 28 U.S.C. § 2241(c).
