ORDERED AND ADJUDGED that the district court's order, filed July 22, 2015, denying relief under Fed. R. Civ. P. 60(b), be affirmed. The notice of appeal, filed August 10, 2015, was timely only as to the order denying appellant's Rule 60(b) motion. The Rule 60(b) motion did not toll the time for noting an appeal from the district court's order entered May 5, 2015, <u>see</u> Fed. R. Civ. P. 59(e) (motion to alter or amend judgment must be filed no later than 28 days after entry of judgment), and "an appeal from the denial of Rule 60(b) relief does not bring up the underlying judgment for review," <u>Browder v. Director, Illinois Dept. of Corrections</u>, 434 U.S. 257, 263 n.7 (1978). The district court did not abuse its discretion in denying the Rule 60(b) motion. <u>See</u> Smalls v. United States, 471 F.3d 186, 191-92 (D.C. Cir. 2006).
