

**MEMORANDUM**

Complainant has filed a complaint of judicial misconduct against a judge of the United States Court of Appeals for the District of Columbia Circuit. For the following reasons, the misconduct complaint will be dismissed.

Complainant asserts that “perjury is misconduct,” but does not point to any particular instance of alleged perjury or other misconduct involving the subject judge. Complainant has also attached to the misconduct complaint the last page of an internet opinion-editorial piece, but that piece does not provide any evidence that the subject judge has engaged in any misconduct. Because the misconduct complaint “lack[s] sufficient evidence to raise an inference that misconduct has occurred,” it must be dismissed. JUD. CONF. RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS, Rule 11(c)(1)(D); see 28 U.S.C. § 352(b)(1)(A)(iii).<sup>1</sup>

<sup>1</sup> Pursuant to 28 U.S.C. § 352(c) and JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS, Rule 18(a), the complainant may file a petition for review by the Judicial Council for the District of Columbia Circuit. Any petition must be filed in the Office of the Circuit Executive for the D.C. Circuit within 42 days of the date of the dismissal order. *Id.* Rule 18(b).
