

MEMORANDUM

The complainant has filed a complaint of judicial misconduct against a judge of the United States District Court for the District of Columbia. For the following reasons, the misconduct complaint will be dismissed.

Complainant filed a civil lawsuit that was assigned to the subject judge. The case remains pending. Complainant alleges that the subject judge is biased in favor of the defendants and “denigrated and defamed” him by making false “public statements suggesting [he] has been a litigant in ‘100s’ of prior cases...” The complaint, however, does not proffer evidence that any false statements were made or that the judge otherwise displayed bias. As the complaint “lack[s] sufficient evidence to raise an inference that misconduct has occurred,” it must be dismissed. JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS 11(c)(1)(D); see 28 U.S.C. § 352(b)(1)(A)(iii).¹

¹ Pursuant to 28 U.S.C. § 352(c) and JUD. CONF. U.S., RULES FOR JUDICIAL-CONDUCT AND JUDICIAL-DISABILITY PROCEEDINGS, Rule 18(a), the complainant may file a petition for review by the Judicial Council for the District of Columbia Circuit. Any petition must be filed in the Office of the Circuit Executive for the D.C. Circuit within 42 days of the date of the dismissal order. *Id.* Rule 18(b).
